Analysis of the Factors Hindering the Improvement of Education Quality at SDN Lambangjaya 02 Tambun Selatan

Abstract: The success of an educational institution is influenced by the quality of education, as education plays a central role in shaping character and preparing future generations. This research aims to analyze the factors that hinder efforts to improve the quality of education at SD Negeri Lambangjaya 02, Tambun Selatan. This research uses a qualitative approach of case study type. Data collection was conducted using interview, observation, and documentation techniques. The data analysis was carried out through data collection, data reduction, data presentation, and drawing conclusions. The research results indicate that the obstacles to improving the quality of education at State Elementary School Lambangjaya 02 include limited facilities and infrastructure, a lack of parental involvement, and challenges in school management. Thus, this requires the role of various elements such as school management, teacher qualifications, parental support, and educational facilities in improving the quality of education.

METHOD

Schools should have facilities and infrastructure such as land, classrooms, administrative offices, teacher rooms, administrative rooms, libraries, laboratories, workspaces, production units, canteens, power and service installations, sports areas, places of worship, and creative spaces. However, the reality is that in that school, several important facilities such as laboratories, a cafeteria, and a prayer room are not available. In fact, the classrooms that are usually used for teaching and learning are often turned into prayer rooms or places of worship. In addition, the condition of the toilets, which often do not have running water, the damaged classroom ceilings, and the limited number of books in the library are also serious issues. Poor network access and the lack of supporting facilities such as laboratories also affect the quality of learning. Although the education standards have been implemented, their execution is often hindered, particularly regarding delays in salary payments. This factor can influence the performance of teachers and the quality of instruction provided to students. In addition, the introduction of the new curriculum, such as the Merdeka Curriculum, has not yet been fully socialized and optimally implemented at State Elementary School Lambangjaya 02.

This issue indicates that meeting the standards for facilities and infrastructure is a top priority in order to improve the quality of education at SD Negeri Lambangjaya 02. The relevant parties, including the government, school committees, and the community, need to collaborate to provide adequate support so that the needs for facilities and infrastructure can be met, creating an optimal learning environment for students and supporting the performance of educators.

An educational institution is a place for the development of a quality generation. Therefore, that institution must be able to create high educational standards to produce a quality generation. To meet the demands for quality education, educational institutions need to be committed and make maximum efforts in managing education so that the desired quality can be achieved. This can be done in various ways. One way is to improve and optimize the management of facilities and infrastructure.

This research reveals that the main issue hindering the quality assurance of education at Lambangjaya 02 Public Elementary School is related to the mismatch of facilities and infrastructure standards. The established standards encompass eight important aspects, ranging from land to creative spaces. The results of the observations and interviews highlight conditions that are far from ideal, with several key facilities such as laboratories, cafeterias, and prayer rooms not available.

A school is considered of high quality if it has adequate facilities and infrastructure. This is because having sufficient facilities and infrastructure supports the learning activities to achieve the desired outcomes. The importance of adequate facilities and infrastructure is not only related to physical comfort but also directly affects the quality of learning (Novita et al., 2017). Factors such as inadequate restroom conditions, damaged classroom ceilings, and a lack of books in the library can hinder the creation of an effective learning environment. One of the main challenges is the use of classrooms as prayer rooms or places of worship. This reflects the mismatch of space functions that can affect students' focus and concentration during learning. The unavailability of laboratories and the lack of supporting facilities can also diminish the school's ability to provide practical experiences that enrich learning (Lestari et al., 2023).

In addition, there is a need for improvement in the management of physical facilities and the learning schedule for students. Nevertheless, the main factor that requires development is the teaching staff, as this is key to improving the quality of education in schools. Therefore, the quality of teachers also needs to be improved while they are carrying out the teaching and learning process. In this case, although educational process standards have been implemented, their execution is often hindered by economic factors, particularly delays in teachers' salary payments. These delays can affect teachers' motivation and performance, potentially harming the quality of instruction provided to students (Brigida Tiwi & Kusnadi, 2021).

The introduction of the new curriculum, such as the Merdeka Curriculum, still faces challenges in socialization and optimal implementation. Lack of support from relevant parties and uneven understanding can slow down the process of adapting to and implementing the new curriculum. Curriculum management is emphasized in the form of activities related to the duties of teachers as well as activities related to the process of teaching and learning implementation (Puput Rahmadani et al., n.d.).

In order to improve the quality of education, priority must be given to meeting the standards of facilities and infrastructure. Collaboration between the government, school

committees, and the community is crucial to provide financial and technical support to ensure that the needs for facilities and infrastructure are met. The improvement of this infrastructure will create a conducive learning environment, support the performance of educators, and optimize the learning potential for students at Lambangjaya 02 Public Elementary School.

CONCLUSION

The conclusion of the research indicates that the main issues at Lambangjaya 02 Public Elementary School are related to the mismatch of facilities and infrastructure standards, such as a lack of amenities like laboratories, a canteen, and a prayer room. Classrooms are often repurposed as prayer rooms, while delays in teacher salaries pose obstacles to meeting educational standards. To address this issue, full support from the government, school committees, and the community is needed.

In its implementation, the government can allocate sufficient budget to ensure the provision of facilities and infrastructure in accordance with standards. The school committee can play an active role in identifying and addressing facility shortcomings, while community participation can involve them in fundraising or other resource efforts. In addition, addressing the delay in teachers' salaries needs to be a priority to maintain their motivation and performance. With strong collaboration, the implementation of this Action is expected to bring about positive changes in improving the quality of education at Lambangjaya 02 Public Elementary School.

In an effort to improve the quality of education at Lambangjaya 02 Elementary School, it is important for the school and the community to collaborate in identifying and addressing the shortcomings in facilities. A sufficient budget allocation must be ensured to meet the required standards of facilities and infrastructure. The school committee can play an active role in this matter, while community participation can also assist in fundraising or other resources. In addition, addressing the issue of delayed teacher salaries should also be a priority to maintain their motivation and performance. With strong collaboration among all parties, the implementation of this Action is expected to bring about significant positive change.

With a solid collaboration among all relevant parties, it is hoped that the implementation of this Action will have a significant positive impact. In addition, it is also important to ensure that the improvement in the quality of education occurs not only at the school level but also involves the entire educational community. Thus, efforts to raise educational standards can continue sustainably and have a long-term impact.
